

24% (n=15372) of all migrants surveyed mentioned desire for family reunification as a factor in their decision to migrate and/or their choice of destination.

In Latin America and the Caribbean, this was the case for 49% (n=5323) of respondents.

> Migrants influenced by desire for family reunification




MMC's regions include Asia, Europe (EUR), Latin America and the Caribbean (LAC), East and Southern Africa (ESA), and West and North Africa (WANA).

A quarter (n= 3770) of migrants influenced by a desire for family reunification needed legal assistance, yet only 5% (n=776) had received any at the time of the interview.


For migrants seeking family reunification, access to information was lowest in Asia and in East and






Among those who accessed information before the journey (n= 11178), 64% used social media or messaging apps as a means of obtaining information prior to migration; during migration, in person was more common.

Family and friends in another country

were the primary sources of information for 77% of migrants who expressed desire for family reunification and accessed information before the journey (n= 11178).


During migration meanwhile, **other migrants** were the most commonly reported source of information, mentioned by 49%. **Local people met on the journey** also emerge as an important new information source.

Europe stands out with regards to the role of **NGOs/UN** as sources of information during migration, cited by 22% (n=142) in the region. Conversely, in Asia, just 1% (n=20) of respondents received information from NGOs/UN during migration.

24% (n=3647) of migrants who expressed desire for family reunification felt they **lacked information** on legal processes regarding migration and asylum.

In **Europe**, this was the case for 46% (n=403) of respondents.

4Mi data collection

4Mi is the Mixed Migration Centre's flagship primary data collection system, an innovative approach that helps fill knowledge gaps, and inform policy and response regarding the nature of mixed migratory movements and the protection risks for refugees and migrants on the move. Note that the sampling approach means that the findings provide rich insights, but the figures cannot be used to make inferences about the total population.
